**Dominion failed to disclose to Congress that the motherboard in the election equipment is not only sourced from China, but it is tested in China. From Leaf's letter here. This is a clear, gross violation of several federal laws. Dominion is toast. See the other letter by Sheriff Leaf in my tweet below -**

Unfortunately, the national security concerns continue. Dominion failed to disclose the use of HuaWei phones utilized by its Serbian employees, the same Serbian employees remoting into the US election system during the US elections.

The Center for Strategic Studies published a report in 2020, Becoming a Chinese Client State: THE CASE OF SERBIA which highlights that China donated HauWei equipment to the Serbian government. Dominion employees in Serbia utilized HauWei phones and had security breaches related to their work at Dominion that they discuss in the email communications. I am attaching a report from the FBI on its concerns related to HauWei and Chinese security risks which increases the concern that Serbia is a critical component to China's digital silk road.

I look forward to assisting Congress with its investigation to resolve these national security concerns.

Dear Congressman Perry:

Please be advised that the Barry County Sheriff's Office has had an open investigation for several years related to election law violations. My office recently received evidence related to this investigation that requires immediate review by Congress.

I am attaching documents directly from Dominion Voting Systems that **demonstrate lack of truthfulness and transparency when testifying before Congress in January 2020. Following the January 2020 hearing, Congress specifically requested information from Dominion regarding the percentage of Chinese parts are used in the Dominion brand election equipment.**

**Dominion failed to disclose to Congress that the motherboard in the election equipment is not only sourced from China, but it is tested in China.** The desire to secrete and hide this information from Congress is concerning considering former Assistant Director of the FBI Counterintelligence has stated Chinese manufacturers can be forced to cooperate with requests from Chinese intelligence officials to share any information about the technology and therefore pose a risk for US companies.

Additionally, testing and modifications are taking place in China on Dominion brand firmware for the HP printers provided by Dominion to local clerks. This changes status of the equipment from "commercial off the shelf" (COTS) to modified equipment which would require EAC certification.

Dominion further failed to disclose to Congress that Dominion employee, Andy Huang, formerly with China Telecom, which is owned by the Chinese Communist Party, was given authority and access to reset the servers on US election equipment remotely from Canada. As you know, the FCC issued Orders to Show Cause on April 24, 2020, against China Telecom stating there is "deep concern" as to the vulnerability to the exploitation, influence, and control of the Chinese Communist Party, given they are subsidiaries of Chinese state-owned entities.

Sheriff Dar Leaf has discovered that Dominion Voting has failed to disclose to Congress that parts of their machines are sourced from China, and tested in China.

In addition, it's alleged that one of Dominion's employees, Andy Huang, was able to access the servers remotely from Canada. Huang once worked for a Chinese telecom known to be a CCP affiliate as well.

Needless to say, such evidence of foreign infiltration of our elections through voting machine companies is a national security emergency on a scale that America has never faced before.
