
# Veteran OBGYN Calls on Lawyers to Represent Babies 'Damaged' by COVID-19 Jabs

"I encourage Plaintiff's attorneys to file civil litigation in these cases. I encourage obstetricians to stand up and speak the truth," says Dr. James Thorp.





Veteran Obstetrician and Maternal Fetal Medicine specialist Dr. James Thorp has issued a grave warning about the risks associated with COVID-19 vaccines in pregnant women and is calling for plaintiff's attorneys to prepare for a surge in litigation related to vaccine injuries.

It's worth noting that Pfizer Inc. safety data—only made available by order of a Texas federal judge—show the company and the U.S. Food & Drug Administration (FDA) have been aware that the shot is linked to numerous negative pregnancy-related outcomes.

Dr. Thorp's statement, posted on his X (formerly Twitter) account, contains a strong condemnation of health policies and alleged unethical agreements among healthcare organizations.

His claims that there is now "irrefutable evidence that hospitals signed secret, unethical, and likely illegal 'cooperative agreements' with HHS CDC in early 2021 to force physicians and employees to push the most deadly and injurious medications ever in the most vulnerable patients- pregnant women and preborns."

Thorp warns that "your futures market in these lucrative 'damaged baby cases' is on the verge of SKYROCKETING."

He criticizes the role of major health organizations, stating that The American College of Obstetricians and Gynecologists (ACOG) and other groups have been influenced by significant sums of taxpayer money to endorse vaccine use in pregnancy.

The OBGYN highlights that the "Freedom of Information Act (FOIA) Documents" show ACOG "accepted millions of dollars of US tax payer moneys to push its 60,000 ObGyn Constituents in two continents (US, Canada, and South America) to follow the lock-step narrative of the lethal HHS/CDC policies."

Discussing his personal experience, Dr. Thorp revealed that "SSM Health of St. Louis MO, a nearly \$10 billion Catholic Hospital System, terminated me on June 29, 2023 because I published extensively on the dangers of the Covid-19 vaccines in pregnancy and testified on multiple high profile public platforms including US Senate, and Tucker Carlson at Fox News as to the dangers of the Covid-19 vaccines in pregnancy."

The veteran obstetrician also questions the integrity of the scientific data supporting vaccine safety in pregnancy, pointing to Pfizer's own data and government reports, which he argues have never been refuted: "Both data sources are biased toward pushing the Covid-19 vaccines in pregnancy."

Highlighting specific risks, Dr. Thorp details findings from Pfizer's phase 2/3 trial, noting stark increases in several severe conditions among newborns whose mothers received the vaccine: "Low Apgar Scores (depressed newborns) increased by 100%," "Meconium Aspiration Syndrome (a life-threatening complication) substantially increased," and "Neonatal Jaundice increased by 80%."

Thorp's concluding remarks underscore his call for accountability and advocacy: "I encourage Plaintiff's attorneys to file civil litigation in these cases. I encourage obstetricians to stand up and speak the truth."

In an exclusive statement to this website, Thorp emphasized how Pfizer's 2021 data revealed its COVID vaccine was exceptionally harmful, particularly in pregnancy, surpassing historical medical disasters, with healthcare systems continuing to advocate its use without adequate follow-up.

"In early 2021, Pfizer's own 5.3.6 post-marketing data showed that it was the most lethal and injurious drug ever rolled out to the public," he said, "The government's own database, the Vaccine Adverse Event Reporting System (VAERS), breached all of their own safety signals for the use of the COVID-19 'vaccines' in pregnancy."

"Moreover, Pfizer's phase 2/3 clinical trial, even though woefully underpowered, documented significant harms to the newborn. The evidence has mounted to the point that it is irrefutable—the harms of the COVID 'vaccines' in pregnancy must be brought to the attention of the public and that of the plaintiffs' attorneys. If this is not done, then the healthcare system/medical organizations' band will continue to play on while the Titanic is sinking. They do not appear capable of righting their own horrific errors," he added.

"The healthcare systems and professional organizations are still pushing this 'vaccine' without long-term follow-up. They have made grave errors making both the Diethylstilbestrol (DES) and

I will support this litigation – it is long overdue. Justice will be served. I encourage Plaintiff's attorneys to file civil litigation in these cases. I encourage obstetricians to stand up and speak the truth. Since when was it ever appropriate to push novel substances in pregnancy without long-term follow up? Didn't we learn from the disasters of Diethylstilbestrol (DES) and Thalidomide?

- 6) Small for Dates (preborn baby with poor growth) substantially increased; (zero in placebo group so no relative risk)
- 7) Congenital Nevus (vascular malformation on the skin) increased by 200%
- 8) Congenital Anomalies and Developmental Delays at 6 months of life increased by 310%

Would your patients have taken the COVID-19 vaccine while pregnant if you informed them that these were potential risks from Pfizer's phase 2/3 trial results? Of course not. No rational individual, especially a pregnant woman, would have considered taking the COVID-19 vaccine in pregnancy had these risks been made known. Did you inform your patients that you were not acting independently, but rather under threat of termination from your hospital system, or under threat from ABOG, ACOG, and SMFM to lose your state license or board certification?


