Dear Secretary Mayorkas:

I write to raise concerns brought to me by whistleblowers about your department’s stunning failure to protect former President Trump on July 13, 2024. As Secretary of Homeland Security (DHS), you are ultimately responsible for your agency and its components, including the U.S. Secret Service (USSS).

Whistleblowers who have direct knowledge of the event have approached my office. According to the allegations, the July 13 rally was considered to be a ‘loose’ security event. For example, detection canines were not used to monitor entry and detect threats in the usual manner. Individuals without proper designations were able to gain access to backstage areas. Department personnel did not appropriately police the security buffer around the podium and were also not stationed at regular intervals around the event’s security perimeter.

In addition, whistleblower allegations suggest the majority of DHS officials were not in fact USSS agents but instead drawn from the department’s Homeland Security Investigations (HSI). This is especially concerning given that HSI agents were unfamiliar with standard protocols typically used at these types of events, according to the allegations.

As a Member of the Senate Homeland Security and Governmental Affairs Committee, which has oversight jurisdiction over your department, I will continue to investigate your department’s role in the staggering security failures on July 13. Unfortunately, your department has not been appropriately forthcoming with Members of Congress—abruptly ending the only call with USSS before most senators could even ask a question. This is completely unacceptable and contrary to the public’s interest in transparency.

Instead, we have learned more from whistleblowers than your department’s officials. I will continue to protect the anonymity and confidentiality of all who contact my office and ensure that they receive the full protections under the law to which they are entitled. So that my office can continue its investigation into the events of July 13, 2024, please provide the following information no later than 7 days from now:

1. How did DHS determine to staff the event, including any decision to rely on state or local officers?

MELUGIN: “The event was staffed by 22 Secret Service agents, including advance, assault, and sniper teams, 16 HSI agents, and it is believed there was no Secret Service drone in the air. Secret Service did not request tactical support from HSI (Homeland Security Investigations) beforehand, including the HSI elite Special Response team. HSI agents were assigned to “post standing” security duties at the street entrance and the

media area, and were not responsible for the close proximity around Trump, or the buildings on the exterior of the area where the shooter was.”

CATES: “HSI are criminal investigators, NOT security specialists. If they were HSI, why would Mayorkas and DHS have kept that under wraps? Why would it take whistleblowers coming forward to reveal this?”

AMUSE: “The majority of undercover agents at the Capitol on January 6th (J6) were members of HSI. The Secret Service Director now has them 'protecting' President Trump? HSI is basically a 'bodyshop' for the FBI and USSS.”

JULIE KELLY: “DHS Secretary Mayorkas is stonewalling the release of a report which would include security failures and the involvement by the Secret Service on January 6.”

MIKE JOHNSON: “DHS Secretary Alejandro Mayorkas is actively trying to block the public testimony of Secret Service Director Kimberly Cheatle.”

Summary of Attempts to Restrict or Delay Access to Information

Section 5(a)(21)(B) of the *Inspector General Act of 1978* (IG Act) requires OIG to report “incidents where the establishment has resisted or objected to oversight activities of the Office or restricted or significantly delayed access to information, including the justification of the establishment for such action.”

DHS Law Enforcement Preparation for and Response to the January 6, 2021 Events at the U.S. Capitol

During the previous reporting period, we included information about Secret Service’s significant delay of OIG’s access to Secret Service records, impeding the progress of our January 6, 2021 review. We continue to discuss this issue with Secret Service.

Let's look at the structure of the department that the Secret Service reports to.

The United States Department of Homeland Security (DHS) is the U.S. federal executive department responsible for public security, roughly comparable to the interior or home ministries of other countries. It began operations on March 1, 2003, after being formed as a result of the Homeland Security Act of 2002, enacted in response to the September 11 attacks.

The creation of DHS constituted the most significant government reorganization since the **Cold War** and the most substantial reorganization of federal agencies since the **National Security Act of 1947** (which had placed the different **military** departments under a **secretary of defense** and created the **National Security Council** and **Central Intelligence Agency**.)

The CIA was created in 1947.

Whereas the Department of Defense is charged with military actions abroad, the Department of Homeland Security (DHS) works in the civilian sphere to protect the United States within, at, and outside its borders.

Homeland Security Investigations (HSI) is a federal law enforcement agency that reports to the Department of Homeland Security (DHS). HSI is the largest investigative arm of DHS, with 26 field offices in the United States and 67 foreign offices in 47 countries.



They put HSI agents together with FBI agents in positions of parity authority on task forces. So, IHMO, HSI is like another CIA with a different name.

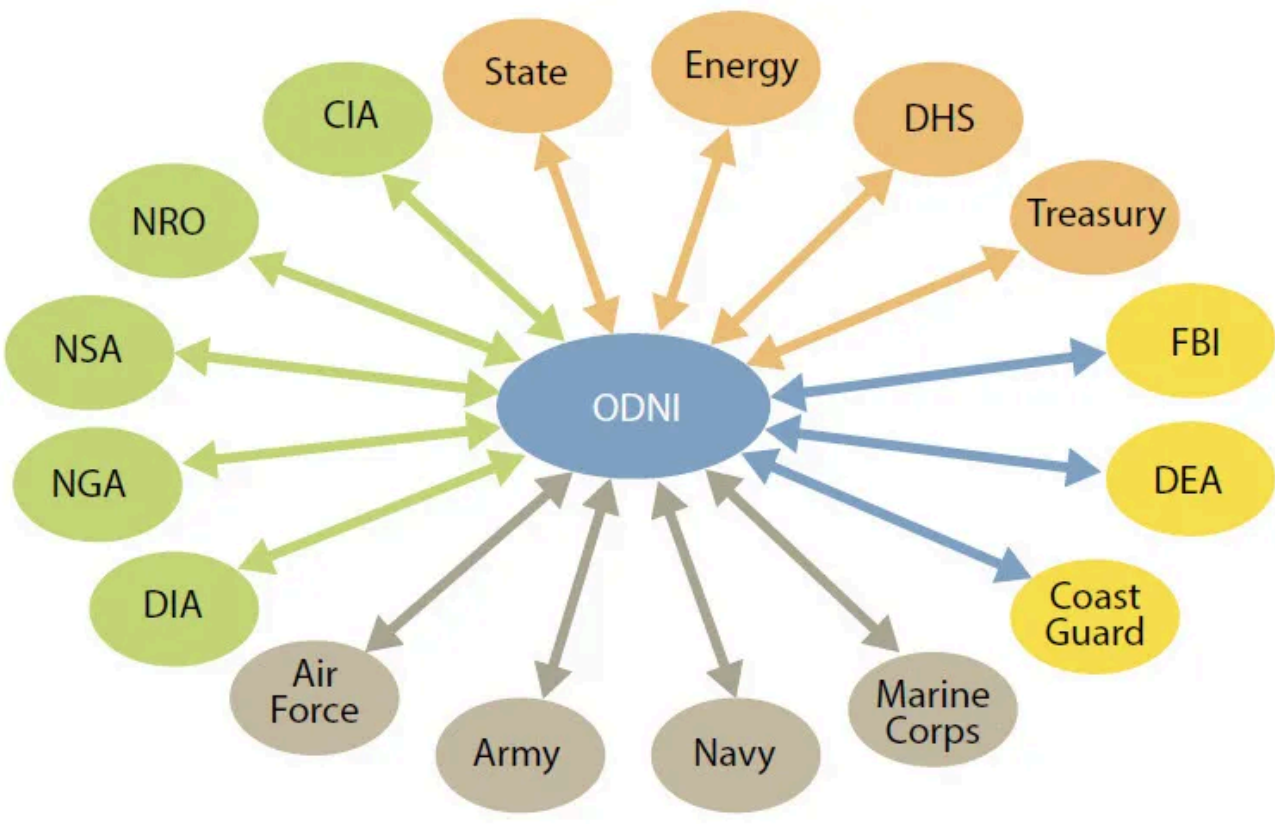

The Secret Service is mandated by Congress to carry out an integrated mission of protection and criminal investigations.

The Office of the Director of National Intelligence (ODNI) started operations in 2005 after an “investigation” proposed a sweeping change in the Intelligence Community (IC) - including the creation of a Director of National Intelligence (DNI). The DNI serves as the head of the IC, overseeing and directing the implementation of the National Intelligence Program (NIP) budget and acting as the principal advisor to the president, National Security Council, and the Homeland Security Council for intelligence matters related to national security.

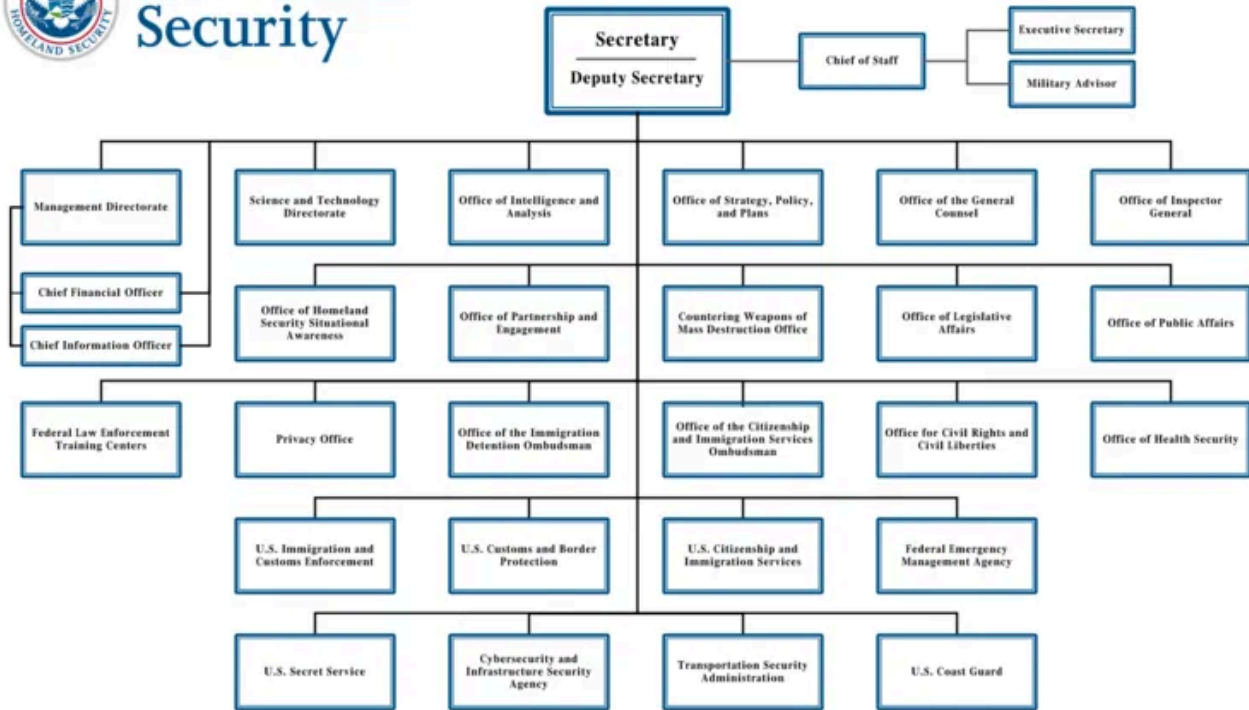
Figure 1. Intelligence Community Network with ODNI as Nucleus
