**Murder of 2456 Alberta cancer patients at Cross Cancer Institute (CCI) in Edmonton**

**Conspiracy to cover up murder of 2456 Alberta Cancer patients at CCI in Edmonton**

**Background:** Emilia Makis and Viliam Makis have been threatened and extorted for money repeatedly in an Extortion Plot that began in April 2021 when Alberta Health Services (AHS) Executive Verna Yiu conspired with CPSA leaders Scott McLeod & Michael Caffaro, and Court of King's Bench Justices Kenneth G. Nielsen, and Avril B. Inglis, to fabricate fraudulent financial damages and inflict them on Emilia Makis and Viliam Makis in order to extort and threaten Viliam Makis into signing a Non-Disclosure Agreement with AHS & CPSA regarding lawsuit QB1603-18935, lawsuit QB1803-16582 and the murder of 2456 Cancer Patients by AHS & CPSA at Cross Cancer Institute in Edmonton, Alberta since 2016, and cover-up of those cancer patient murders.

**The criminal incidents are briefly summarized as follows** (supporting documents attached as Exhibits):

1. **Aug.4, 2024** – CPSA conspirators sent two Edmonton Police Officers to the home of Emilia Makis & Viliam Makis on the basis of a fabricated and fraudulent complaint, with intent to intimidate.
2. **Dec.23, 2023** – CPSA conspirators sent two letters to the home of Emilia Makis & Viliam Makis, extorting them for money with a fraudulent "Writ of Enforcement" against their home (**Exhibit A**)

3. **Nov.13, 2023** – A threatening extortion email was sent by Mylene Tiessen on behalf of CPSA extorting money from the Makis family with fraudulent Court documents for \$33,682 and \$18,145 (**Exhibit B**).
4. **Nov.8, 2023** – **Court Fraud** - Mylene Tiessen represented CPSA conspirators in a fraudulent Court process lead by lawyer and “Court Assessment Officer” **Dennis Pawlowski** where extortion amounts against Emilia Makis & Viliam Makis were plotted, signed and filed with Court.
5. **Oct.17, 2023** – A threatening extortion email was sent by Mylene Tiessen on behalf of CPSA proposing to extort money from the Makis family via fraudulent Court documents (**Exhibit C**)
6. **Aug.10, 2023** – A threatening extortion email was sent by Mylene Tiessen regarding Court Action of July 7, 2023 (**Exhibit D**)
7. **Aug.09, 2023** – A threatening extortion email was sent by Mylene Tiessen regarding Court Action of July 7, 2023 (**Exhibit E**)
8. **Aug.03, 2023** - A threatening extortion email was sent by Mylene Tiessen regarding Court Action of July 7, 2023 (**Exhibit F**)
9. **Jul.19, 2023** - A threatening extortion email was sent by Mylene Tiessen regarding Court Action of July 7, 2023 (**Exhibit G**)
10. **Jul.7, 2023** – **Court Fraud** – Mylene Tiessen committed fraud at Court of Appeal on behalf of CPSA Conspirators, and conspired with Justice Dawn Pentelchuk to extort an additional \$40,000 from Dr.Makis and sabotage Dr.Makis’ appeal of Justice Inglis and Justice Lee’s Court Decisions of March 28, 2023 and April 21, 2023, both of which CPSA used for Extortion and threats of the Makis family.
11. **Jun.21, 2023** – **Court Fraud** – Mylene Tiessen filed a fraudulent Court document on behalf of CPSA Conspirators (**Exhibit H**)
12. **May 10, 2023** – Mylene Tiessen sent email regarding Court Fraud that took place on April 21, 2023 in conspiracy with Justice Donald Lee (**Exhibit I**)
13. **April 21, 2023 (Court Hearing)** – Mylene Tiessen committed fraud in Court by filing fraudulent Court documents and lying in Court, in conspiracy with Justice Donald Lee who illegally sabotaged Dr.Makis’ lawsuit QB1603-18935 and removed CPSA as a co-defendant on the basis of a fraudulent application filed by CPSA (**Exhibit J**)
14. **Mar.30, 2023** - Mylene Tiessen sent an email regarding Court Fraud on April 21, 2023 (**Exhibit K**)
15. **Mar.29, 2023** - Mylene Tiessen committed fraud in Court on Jan.18, 2023 in conspiracy with Justice Avril B. Inglis (**Exhibit L**)
16. **March 28, 2023** – **Court Fraud** – Mylene Tiessen committed fraud in Court on behalf of CPSA Conspirators in conspiracy with Justice Avril B. Inglis (**Exhibit M**)
17. **Jan.18, 2023 (Court Hearing)** – **Court Fraud** - Mylene Tiessen committed Court fraud in conspiracy with Justice Avril B. Inglis by filing fraudulent documents and lying on the Court record (**Exhibit N**)
18. **Dec.15, 2022** – Viliam Makis re-filed an Affidavit in Court removing names of 2456 Cancer patients who were murdered by AHS and CPSA, after threats by AHS & CPSA legal counsels, Dr.Makis filed 2 Affidavits one of which was illegally struck by Justice Avril Inglis to cover-up patient murders (**Exhibit O**)
19. **Dec.5, 2022** – AHS Officials and Mylene Tiessen conspired to remove the names of 2456 murdered Cancer patients from the Court Filing of sworn Affidavit of Viliam Makis filed Nov.30, 2022. (**Exhibit P**)
20. **Oct.18, 2022** – Mylene Tiessen committed Court fraud during Case Management meeting on July 26, 2022 by filing fraudulent Court documents and lying on Court record. (**Exhibit R**)

21. **July 26, 2022 (Case Management Court Meeting)** - Mylene Tiessen committed Court fraud during Case Management meeting on July 26, 2022, where she lied on Court record.
22. **Apr.20, 2022** - Mylene Tiessen committed Court fraud with a fraudulent Application to remove CPSA as a co-defendant in QB1603-18935 (**Exhibit S**)
23. **Apr.6, 2022 (Case Management Court Meeting)** – Mylene Tiessen committed Court fraud during a Case Management meeting on April 6, 2022 in conspiracy with Justice Avril B. Inglis. During this meeting, CPSA Conspirators plotted with Justice Inglis the details of the Extortion Plot that would take place via CPSA’s fraudulent application to have CPSA removed as a Co-Defendant in QB1603-18935, filed by Mylene Tiessen on Apr.27, 2020. (**Exhibit T**)
24. **Aug.25, 2021** – Mylene Tiessen committed Court Fraud by advancing a fraudulent Application to dismiss CPSA as a co-defendant in Dr.Makis’ lawsuit QB1603-18935 (**Exhibit U**)
25. **May 4, 2021** – Court of King’s Bench Justice Avril B. Inglis was brought into the Extortion Plot by AHS and CPSA conspirators, via appointment by Associate Chief Justice Kenneth G. Nielsen who chose Justice Inglis for the specific purpose of advancing AHS and CPSA’s Extortion Plot (**Exhibit V**)
26. **May 1, 2020 (Court of Appeal Fraud)** - Mylene Tiessen committed Court Fraud in the Court of Appeal Hearing 2020 ABCA168, by lying on Court record and filing fraudulent documents (**Exhibit W**)
27. **Apr.15 and Apr.27, 2020** – Two fraudulent Court Applications were filed by Mylene Tiessen that would form the basis of the 2020-2024 Extortion Plot against the Makis family, as well as prevent Michael Caffaro from being questioned under oath by Dr.Makis in QB1603-18935 in Discovery (**Exhibit X**)
28. **Jan.28, 2020 – Court Fraud** - Mylene Tiessen committed fraud in Court of King’s Bench Hearing in 2020 ABQB245 (**Exhibit Y**)
29. **Jan.9, 2020 – Court Fraud** - Mylene Tiessen Committed fraud at Court of Appeal Hearing in 2020ABCA168 by lying to the presiding Justices Slatter, Justice Veldhuis and Justice Bielby (**Exhibit Z**)
30. **Nov.8, 2018** – Edmonton Police Detective Kevin Schindeler (#Reg2049) covered up a criminal complaint (EPS File #18-132308) filed by Dr.Makis against CPSA Lawyer Craig Boyer and his partner William Hembroff regarding multiple threats against Emilia Makis & Viliam Makis: (**Exhibit AA**)
  - **Oct.29-30, 2018** – Caffaro threatened and extorted Dr.& Mrs.Makis, s.346, s.465
  - **Jul.10-18, 2018** – Caffaro, Boyer, Hembroff extorted Dr.& Mrs.Makis, s.346, s.465
  - **Jul.5, 2018** – Caffaro, Boyer threatened and extorted Dr.& Mrs.Makis, s.346, s.465
  - **Jun.5, 2018** – CPSA initiated extortion of Dr.& Mrs.Makis in Hearing Decision, s.346, s.465
  - **Jan.15-16, 2018** – Caffaro, Boyer attacked & threatened Dr.Makis at CPSA Hearing, s.465
  - **Oct.16, 2017** – Caffaro, Boyer initiated CPSA Hearing, threatened Dr.Makis, s.465
  - **June 12, 2017** – Caffaro launched a fraudulent CPSA Investigation, threatened Dr.Makis, s.465
31. **June 2-9, 2017** – Viliam Makis was offered a \$400,000 settlement to settle QB1603-18935 by AHS lawyer Mark Jackson, which Viliam Makis rejected, and 6 business hours later, CPSA initiated first threats against Viliam Makis on June 12, 2017 by Michael Caffaro and his lawyer Craig Boyer, which led to the entire sequence of events above, including the 2020-2024 Extortion Plot which centers around QB1603-18935 and attempts by both AHS and CPSA to strike the lawsuit or get out of it using fraudulent Court Applications. (**Exhibit AB**)
32. **Dec.2015** – AHS and CPSA Officials conspired to murder 2456 Alberta Cancer patients at Cross Cancer Institute, who were diagnosed or treated by Dr.Makis in a large Clinical Trial NCT01876771.

**Summary:**

In the fall of 2015, AHS CEO Verna Yiu, AHS VP Francois Belanger and CPSA Leaders Trevor Theman and Michael Caffaro conspired to murder or inflict serious bodily harm on Dr.Makis' 2456 Cancer patients at Cross Cancer Institute. AHS illegally prevented Dr.Makis from working and treating his Cancer patients during 2016. In the fall of 2016 Dr.Makis filed a \$13.5 million lawsuit QB1603-18935 and added CPSA as a co-Defendant.

During June 2-9, 2017, Dr.Makis was offered a **\$400,000** settlement to settle QB1603-18935 which required Dr.Makis to sign a Non-Disclosure Agreement with AHS. Dr.Makis rejected this offer on June 9, 2017.

Within 6 business hours of Dr.Makis' rejection of the \$400,000 AHS settlement, CPSA leader Michael Caffaro and his lawyer Craig Boyer started threatening Dr.Makis and initiated a fraudulent complaint on June 12, 2017, which they pursued until 2019 through a CPSA Hearing Tribunal, during which they ran up the legal costs to \$74,453. They then threatened and extorted Viliam Makis and Emilia Makis with the \$74,453 CPSA Hearing Costs they fabricated, threatening Dr.Makis' family and Medical License #023044 in the process, threatening they would terminate Dr.Makis' license if he didn't sign the Non-Disclosure Agreement with AHS.

These threats and extortion were filed as a Criminal Complaint with the Edmonton Police Service on Sep.10, 2018 and again on Nov.8, 2018, which were brought to the attention to **Edmonton Police Service Detective Kevin Schindeler (Reg#2049)** who failed to act on the Criminal Complaint and failed to investigate it.

In Aug.2018, CPSA leaders Scott McLeod and Michael Caffaro brought a fraudulent Court Application in conspiracy with AHS to have Dr.Makis' lawsuit QB1603-18935 struck as vexatious, however, this application failed in Dec.3, 2018 in Justice Clackson's Court Decision 2018 ABQB976 and failed again at the Court of Appeal on May 1, 2020 in 2020 ABCA168. The lawsuit QB1603-18935 continued into Discovery Examinations.

Calgary lawyer Mylene Tiessen joined the conspiracy as new CPSA legal counsel in May 2019. On April 15, 2020 and April 27, 2020 she filed two fraudulent Court Applications against Dr.Makis that would serve as the basis for the 2020-2024 Extortion Plot against Emilia Makis and Viliam Makis and she informed Dr.Makis that she would not allow Dr.Makis to question Michael Caffaro under oath in Discovery for QB1603-18935.

In late 2019, AHS and CPSA brought a fraudulent emergency application to Court to have Dr.Makis silenced by Court on Twitter and other social media and have his Charter Rights to Freedom of Expression suspended by Court, but this application failed and was dismissed by Justice Clackson in 2020 ABQB245.

Given that AHS and CPSA had failed in two very expensive Court battles against Dr.Makis in 2020, (having failed to silence Dr.Makis on Twitter in 2020 ABQB245 and also failing in 2020 ABCA168), Associate Chief Justice Kenneth G.Nielsen, who is part of the Extortion Plot, appointed a new Case Management Judge to oversee Dr.Makis' lawsuits, Justice Avril B.Inglis, on April 23, 2021 to co-ordinate the Extortion Plot against Emilia Makis and Viliam Makis in conspiracy with AHS and CPSA and move it forward in Court. **(Exhibit AC)**

Justice Avril Inglis began coordinating the Extortion Plot against Emilia Makis and Viliam Makis immediately, demanding a Case Management Conference, which took place on July 28, 2021, while ignoring Dr.Makis' concerns about AHS and CPSA abusing Court processes in a letter dated June 24, 2021 **(Exhibit AD)**.

Through multiple Case Management Conferences held on April 6, 2022 and July 26, 2022, Justice Avril Inglis carefully co-ordinated the Extortion Plot by co-ordinating all of the Court Dates, to ensure that the Court Applications she intended to interfere with and manipulate, were perfectly coordinated time-wise to inflict maximum financial damages on Emilia Makis and Viliam Makis, in the shortest period of time.

Accordingly, Justice Inglis sabotaged Dr.Makis' application in QB1603-18935 to have AHS and CPSA declared vexatious litigants on March 28, 2023 and coordinated with two other Court of King's Bench Judges to ensure they would sabotage both of Dr.Makis' lawsuits within days of each other.

Justice Inglis co-ordinated 4 key Extortion Plot events, during the period March 28, 2023 to April 21, 2023, which are described below:

- March 28, 2023 – 2023 ABKB183 – **Justice Avril Inglis** sabotaged Dr.Makis' Application to have AHS and CPSA declared vexatious litigants (QB1603-18935) – extortion costs awarded by Inglis: \$18145
- March 28, 2023 – 2023 ABKB184 – **Justice Avril Inglis** sabotaged Dr.Makis' Application to have AHS and University of Alberta defendants declared vexatious litigants (QB1803-16582) – extortion costs pending
- March 30, 2023 – 2023 ABKB196 – **Justice John Gill** sabotaged Dr.Makis' lawsuit QB1803-16582 against AHS Officials and University of Alberta – extortion costs awarded by Gill: \$21948
- April 21, 2023 – ORDER of **Justice Donald Lee**, sabotaged Dr.Makis' lawsuit QB1603-18935 by illegally removing CPSA as a co-defendant (no Decision was ever filed), extortion costs awarded by Lee: \$33682

Each of these dates: March 28, March 30 and April 21, 2023 was selected and co-ordinated by Justice Avril Inglis. Once these fraudulent Court Decisions were issued, Justice Inglis coordinated with Justice John Gill and Justice Donald Lee to ensure that exorbitant and fraudulent Court Costs would be awarded to both AHS and CPSA to allow them to Extort and Threaten Emilia Makis and Viliam Makis. These are described below:

- July 7, 2023 – ORDER of **Justice Dawn Pentelechuk**, sabotaged Dr.Makis' Appeal of the above four actions and extorted Dr.Makis for an additional \$40000 in order to be able to continue the Appeal
- Sep.13, 2023 – ORDER of **Justice Inglis** awarded fraudulent costs to AHS and CPSA and conspired with "Assessment Officer" Dennis Pawlowski to hold a Hearing on Nov.8, 2023 where he would award AHS and CPSA with exorbitant costs against Emilia Makis and Viliam Makis (\$33682 and \$18145).
- Jan.29, 2024 – ORDER of **Justice Avril Inglis** regarding a fraudulent Application filed by AHS using confidential UCP Alberta Government emails illegally leaked by UCP Minister of Health staff and Alberta Premier Danielle Smith Office staff to AHS lawyers – extortion costs of \$10,000 awarded to AHS
- **Justice Kenneth G. Nielsen** oversaw the entire Extortion Plot from beginning by appointing Justice Avril Inglis on April 23, 2021 to "manage" Dr.Makis' two lawsuits QB1603-18935 and QB1803-16582.
- The entire Extortion Plot amount is **\$123,775** to date and involves criminal acts by 5 Alberta Judges: **Associate Chief Justice Kenneth G.Nielsen, Justice Avril B.Inglis, Justice Donald Lee, Justice John Gill and Justice Dawn Pentelechuk** – criminal complaints will be filed against each Judge separately.

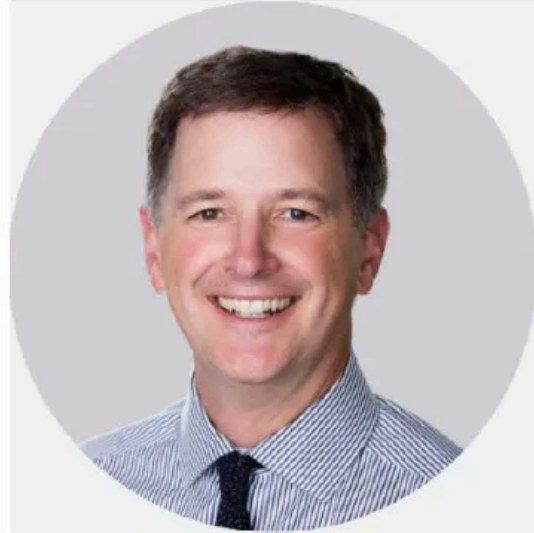
