FROM: THE ACTING DEPUTY ATTORNEY GENERAL *EB 1/31/25*

SUBJECT: Terminations

You are directed to take all steps necessary to effectuate the termination of the employees identified in Appendix A, effective immediately. It is my understanding based on information provided by EOUSA and JMD that these employees are still within the probationary period associated with their hiring processes, and that they were initially hired as term employees at the U.S. Attorney's Office for the District of Columbia to support casework relating to events that occurred at or near the United States Capitol on January 6, 2021. In an Executive Order issued on January 20, 2025, President Trump appropriately characterized that work as having involved "a grave national injustice that has been perpetrated upon the American people over the last four years."

It is also my understanding based on information provided by EOUSA and JMD that, after President Trump was elected to his second term in Office, the Biden Administration's Justice Department converted these employees to permanent status. The manner in which these conversions were executed resulted in the mass, purportedly permanent hiring of a group of AUSAs in the weeks leading up to President Trump's second inauguration, which has improperly hindered the ability of Acting U.S. Attorney Martin to staff his Office in furtherance of his obligation to faithfully implement the agenda that the American people elected President Trump to execute.

I will not tolerate subversive personnel actions by the previous Administration at any U.S. Attorney's Office. Too much is at stake. In light of the foregoing, the appropriate course is to terminate these employees, and to take all appropriate steps to ensure that resources allocated to their hiring and employment is available to Acting U.S. Attorney Martin for merit-based hiring.

Finally, the circumstances of the conversions are the subject of an ongoing inquiry at the Justice Department, including pursuant to President Trump's January 20, 2025 Executive Order entitled, "Ending The Weaponization Of The Federal Government." Please take all steps necessary to preserve all records, including documents, emails, text messages, and other electronic communications, relating to the conversions and other personnel decisions regarding attorneys hired to support casework relating to events that occurred at or near the United States Capitol on January 6, 2021.


