
Judicial Coup

Liberal judges are trying to use court orders to delay or stop President Trump from using his authority to protect America from domestic and foreign threats and deporting a "Judicial Coup."


The information on this is confusing and coming out in bits and pieces and I haven found anyone reporting the entire story - so I thought I'd do that. Here's what I kno so far:

So, Trump's plan bypassed Maduro's nonsense and involved sending the TdA gangs to El Salvador's mega-prison, the Terrorism Confinement Center (CECOT), under a agreement with President Nayib Bukele, who accepted them for a fee, reportedly \$6 million for 300 migrants over a year. If America were to keep the illegal alien gangs here on American soil - instead of deporting them - the cost to American taxpayers would be over \$200 million, not \$6 million.

So far, the illegal alien TdA gang members have been arrested hundreds of times in US - for crimes including drug trafficking, human trafficking, sexual assault, terrorism, theft, murder, attempted murder and kidnapping. The murder victims so

include 22-year old Laken Riley of Georgia, 33-year old Arneaud-Petit in Texas, a retired police officer in Florida and the attempted murder of 2 New York police officers.



Tren de Aragua began in the early 2010s in Tocorón prison, located in Venezuela's Aragua state, about 80 miles southwest of Caracas. It emerged under the leadership "Niño Guerrero" who was imprisoned in 2005 for murdering a police officer.



By 2014, Guerrero and his associates had transformed the gang into a powerful "megabanda" within the prison. Under the "pran" system - where crime bosses run prisons with Maduro's approval - Tren de Aragua turned Tocorón into a criminal headquarters, complete with a zoo, nightclub, and pool, funded by extortion, drug trafficking, and kidnappings.

In other words, the Communist dictator of Venezuela let TdA run the prison and liv like Kings within it.

In September 2023, Maduro's forces allegedly raided Tocorón with 11,000 troops, bu Guerrero and key leaders escaped, possibly tipped off, and the gang's operations have continued unabated across borders, including into the U.S.



Maduro's United Socialist Party (PSUV) has denied that the gang exists anymore right - but the President of El Salvador - Nayib Bukele - says that Maduro deliberately emptied his prisons and sent them north to invade and terrorize America.

The gang's brutal tactics - torture, beheadings, maiming and burying victims alive - are well-documented in Latin America. President Trump does not want to allow the to continue and fester in the US.

To get them out quickly, President Trump invoked the Alien Enemies Act of 1798, a rarely used wartime statute that allows the president to detain, arrest, and deport noncitizens over 14 years old from a nation deemed an enemy during a declared war when facing an "invasion or predatory incursion." Historically, it was used during the War of 1812, World War I, and World War II.

It reads:

50 U.S.C. § 21 - Restraint, regulation, and removal of alien enemies:

"Whenever there is a declared war between the United States and any foreign natio or government, or any invasion or predatory incursion is perpetrated, attempted, or threatened against the territory of the United States by any foreign nation or government, and the President makes public proclamation of the event, all natives, citizens, denizens, or subjects of the hostile nation or government, being of the age fourteen years and upward, who shall be within the United States and not actually naturalized, shall be liable to be apprehended, restrained, secured, and removed as alien enemies.

The President is authorized, in any such event, by his proclamation thereof, or othe public act, to direct the conduct to be observed, on the part of the United States, toward the aliens who become so liable; the manner and degree of the restraint to which they shall be subject and in what cases, and upon what security their residen shall be permitted, and to provide for the removal of those who, not being permitted within the United States, refuse or neglect to depart therefrom; and to estable any other regulations which are found necessary in the premises and for the public safety."

On Friday, March 14, 2025, President Trump signed a proclamation invoking the Al Enemies Act to deport members of the Venezuelan gang Tren de Aragua.

On Saturday, March 15, 2025 - this is the timeline of actions that followed in ET:

- 2:00 AM: ACLU and Democracy Forward filed a lawsuit on behalf of five Venezuelans.
- 9:40 AM: Judge James E. Boasberg issued a temporary restraining order halting deportations.
- 3:51 PM: The White House announced Trump's invocation of the Alien Enemie Act.
- 5:25 PM: First deportation flight (G66143) departed from Harlingen, Texas.
- 6:47 PM: At an emergency hearing on the Alien Enemies Act, Boasberg demand that the planes turn around.
- 7:37 PM: First deportation flight arrived in Honduras.
- 8:10 PM: Second deportation flight (G66145) arrived in Honduras.

- 11:39 PM: First deportation flight departed Honduras for El Salvador.
- 11:43 PM: Second deportation flight departed Honduras for El Salvador.

Sunday, March 16, 2025

- 12:10 AM: First deportation flight landed in El Salvador.
- 12:18 AM: Second deportation flight landed in El Salvador.
- 7:46 AM: El Salvador's President Nayib Bukele tweeted about the arrivals.
- 8:13 AM: Bukele announced that the U.S. paid El Salvador to detain 238 alleged gang members.
- 9:15 AM: White House Press Secretary announced the removal of nearly 300 "T De Aragua terrorists" to El Salvador.

During an emergency hearing, Boasberg blocked the use of the Alien Enemies Act 1 deport non-citizens in custody, and when he was informed the planes were already airborne, he verbally ordered them returned to the U.S. at 6:46 p.m., saying, "Any pl containing these folks... needs to be returned to the United States... Make sure it's complied with immediately." The fake news made it sound like Boasberg did this lo before Trump's executive order took effect. More lies.

May God bless El Salvador, and may God bless the United States."



On March 17, after the planes had landed and during a follow-up hearing, Boasberg accused DOJ lawyers of ignoring his order, rejecting their claim that verbal directiv weren't binding or that planes over international waters were beyond his jurisdictic He called their arguments a "heck of a stretch" and extended the TRO for 14 days to litigate the law's legality.

Strangely, right after that, the Chief Justice of the Supreme Court, John Roberts, responded to Trump's actions issuing a rare public statement to defend Judge Boasberg:

"For more than two centuries, it has been established that impeachment is not an appropriate response to disagreement concerning a judicial decision. The normal appellate review process exists for that purpose."



Attorney General Pam Bondi blasted Boasberg's ruling as baseless, insisting the fliq were lawful. Rep. Brandon Gill (R-TX) filed impeachment articles against Boasberg March 18, joined by five GOP co-sponsors, calling him an "activist judge" guilty of "high crimes." Elon Musk, Tom Fitton & Marco Rubio all defended Trump.

In 1801, President John Adams, just before leaving office, appointed a series of federal judges known as "Midnight Judges" to secure Federalist influence in the judiciary as Thomas Jefferson's Democratic-Republicans took power. The Judiciary Act of 1801 expanded the courts, allowing Adams to pack them with loyalists, but Jefferson's administration later repealed the act and abolished many of those judgeships, effectively removing the appointees. Applying this to today, rogue federal judges perceived as obstructing President Trump's agenda could face similar pushback. Congress, if aligned with Trump, might defund certain courts or restructure judicial positions through legislation, reducing their authority or eliminating seats altogether. Alternatively, impeachment remains an option for removing individual judges, though it's a high bar requiring significant political will and evidence of misconduct.



That's a SIMPLE MAJORITY in the House and Senate--and you DO have THAT.



A judicial coup is when a country's judiciary, typically its highest court, takes action that significantly alter or undermine the democratic process, elected government, of constitutional order, often in a way that's perceived as overstepping its legal author

Unlike a military coup, which involves force, a judicial coup uses legal mechanisms take power and consolidate control and uses judges, who aren't elected, to override will of the people or their representatives.

Is what happened in El Salvador a judicial coup? No, Bukele impeached and remove corrupt judges that were obstructing his mandate to fix the country.

After Bukele's Nuevas Ideas party won a supermajority in the February 2021 legislar elections, the new Congress, on May 1, 2021, voted to remove all five judges of the Supreme Court's Constitutional Chamber and the Attorney General.

Bukele defended it as "cleaning our house" claiming the judges were corrupt and obstructed his mandate to fix the country.

BUKELE: "That's exactly what judges were doing in El Salvador in 2021. So we impeached them all and then proceeded to fix the country."

Israel also didn't exactly experience a "judicial coup" but it has faced similar dynam. In 2023, the Netanyahu government pushed judicial reforms to limit the Supreme Court's ability to strike down laws and control judicial appointments, arguing the liberal court's activism undermined elected officials.

Other countries have faced events labeled as judicial coups:

- 1. Pakistan (2022) The Supreme Court intervened in a political crisis when Prime Minister Imran Khan dissolved parliament to avoid a no-confidence vote.
- 2. Romania (2024) On December 6, 2024, Romania's Constitutional Court annulle the presidential election results, citing irregularities. This sparked outrage acre the political spectrum, with many labeling it a judicial coup.
- 3. Venezuela (2017) The Supreme Court, packed with Communist loyalists to President Nicolás Maduro, stripped the opposition-led National Assembly of legislative powers, transferring them to itself. Labeled a judicial coup by critics effectively dissolved opposition.
- 4. Thailand (2008) The Constitutional Court dissolved the ruling People's Power Party (PPP) over electoral fraud, ousting PM Somchai Wongsawat and banning key politicians. Seen as a judicial coup backed by the military and monarchy, it shifted power.

F you ever doubted that Washington's corrupt cartel of Democrat law firms, judges, NGOs, and deep state bureaucrats is a machine designed to thwart the Trump administration, just watch as judge after judge blocks the president's ability to keep his campaign promises.

It may not be brown paper bags changing hands, but this lawfare that defies the people's will is ev-

ery bit as corrupt.

It will be up to the Supreme Court to define the limits of presidential authority, but Chief Justice John Roberts' preemptive scolding of Trump for musing about judicial impeachment doesn't bode well for the president.

Trump won a thumping mandate in the November election, winning every swing state, the popular vote and both houses of Congress. Democrats are rudderless, fighting each other and incapable of mounting an effective opposition.

So they are depending on the federal courts to be the "Last Bul-wark Against Trump" as The New York Times puts it, celebrating the fact that almost 600 federal judges in courtrooms from Rhode Island to Seattle can issue emergency rulings to "stop the White House in its tracks."

Politico has dubbed it the "court case presidency," noting approvingly that "the courts have provided the only real opposition to Trump 2.0 so far."

And so they have. According to Attorney General Pam Bondi, judges issued more than l4 injunctions against Trump's administration actions in February alone, with 160 "resistance" lawsuits winding their way through the system.

For example, we had Judge James Boasberg, an Obama appointee, blocking the deportation of illegal alien criminals deemed a national security threat.

Judge Theodore Chuang, an Obama appointee, blocked DOGE's dismantling of USAID, which turned out to be a slush fund for shady Democrat projects rather than a foreign aid agency, and ordered a stop to the freeze on \$2 billion being sent out of the country.

Judge Ana Reyes — a Biden appointee — blocked Trump's executive order banning transgender individuals from military service.

White House press secretary Karoline Leavitt weighed in at her press conference Wednesday, pointing out that "67% of all of the injunctions in this century have come against... President Donald Trump... and 92% of those have been from Democrat-appointed judges. This is a clear concerted ef-



fort by leftists who don't like this president and who are trying to oppose or slow down his agenda."

The judge who has most angered Trump is Boasberg (pictured), chief judge of the notoriously left-leaning Washington, DC, District Court who convened an emergency hearing Saturday to block the deportation of 251 dangerous illegal alien criminals, going so far as ordering the planes be turned around midair.

Midair disaster attempt

Trump had invoked the Alien Enemies Act of 1798 Saturday to deport two planeloads of the Venezuelan gang Tren de Aragua, which he declared are "perpetrating, attempting, and threatening an invasion or predatory incursion... and conducting irregular warfare against the territory of the United States... at the direction, clandestine or otherwise, of the Maduro regime in Venezuela"

regime in Venezuela."

The planes landed in El Salvador, which is being paid \$6 million to detain the deportees for a year, as part of the Trump administration's crackdown on Joe Biden's disastrous illegal migration project.

"One unelected federal judge trying to control foreign policy," railed Attorney General Bondi Wednesday. "There are 251 reasons why Americans are safer now because those people are out of this country."

But Boasberg has stepped up his pressure, demanding DOJ lawyers provide minute details of the flights — potentially to hold members of the administration in contempt and serve as the basis for a future impeachment of Trump. Trump lambasted Boasberg

Trump lambasted Boasberg Tuesday as a "radical left lunatic, a troublemaker and agitator," and called for his impeachment. Some Republican members of the House are moving to impeach the judge for what they say was a "lawless" order that endangered national security.

"The judge in this case put the lives of every single person on those aircraft at risk," White House deputy chief of staff Stephen Miller told CNN.

"Did he know how much fuel was in those planes? Did he know the flight conditions? Did he know the weather conditions? Did he know how many crew hours? Did he know the need for crew rest? Did he know any of that? No. This judge violated the law. He violated the Constitution

"These same district court judges didn't do a damn thing to stop Joe Biden from flooding this nation with millions of illegal aliens, didn't issue any injunctions to save the lives of Jocelyn Nungaray or Laken Riley . . . How are you going to expel illegal alien invaders from our country who are raping, murdering little girls if each and every deportation has to be adjudicated by a district court judge?"

Back with a vengeance

The same lawfare that haunted Trump's first term and dogged his four years in the wilderness is back with a vengeance.

After the Russia hoax and two impeachments, Trump's enemies used the courts to try to bankrupt him, throw him in prison and take him off the ballot. When all else failed, they tried to assassinate him.

But the lawfare only made him stronger as the American people woke up to the ruse. Now his mug shot has pride of place in a framed New York Post cover in a corridor off the Oval Office.

"They can't help themselves,"
says attorney and legal commentator Mike Davis, who founded the
Article III Project to push back on
lawfare against conservatives.

Davis wants Boasberg impeached and says even if the attempt isn't successful, the process would be worth it to act as a deterrent to other activist judges.

In her press conference Wednesday, Leavitt read off a list of dangerous criminal aliens captured ir recent days by ICE agents around the country, who should be next or Trump's deportation list, if only ac tivist judges get out of the way. In San Francisco, ICE arrested:

In San Francisco, ICE arrested : citizen of Guatemala convicted o sexual battery. In New Orleans they nabbed an Ecuadorian citizer convicted of rape in Long Island In Dallas, another Mexican wapicked up with convictions for as sault with a fireram and "rape with a foreign object." Houston ICE ar rested a Guatemalan convicted o indecent sexual contact with ichild.

"These are heinous crimina alien monsters who the previou administration allowed to floor into this country," said Leavitt.

Yes, and these are the monster that the Democrat lawfare machin is working overtime to keep in the country, in opposition to a president who is doing what he waelected to do.

The Supreme Court needs to rei in the lawfare, or we don't have country.

GROK: "These nationwide injunctions aren't explicitly authorized by any statute—they've evolved through judicial practice and their use has ballooned under Trump. The Supreme Court could curb this. Until the high court reins them in, there's no

strict legal cap on their scope. The Supreme Court hasn't fully settled their limits, though Justices like Gorsuch and Thomas have grumbled they overstep, risking "on judge vetoes" over national policy. The Supreme Court is the only body that can definitively rein them in. Gorsuch in 2018 called them "cosmic" and questioned the legitimacy; Thomas has said they "undermine core principles" of judicial restraint. the Court hasn't banned them outright."
